# Investment Policy

The portfolio invests in unit trusts and maintains an overall medium to high risk profile with the expected equity exposure ranges between 55% and 75% of its net asset value, whilst its property exposure ranges between 0% and 25% of its net asset value. In order to achieve its objective, the underlying managers investments normally included in their portfolio may comprise a combination of assets in liquid form, money market instruments, interest-bearing securities, sources, and depending sources, corporate debt, equity securities, other interest-bearing securities, property securities, preference shares, convertible equities and non-equity securities. The underlying managers may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy.


The portfolio is likely to suit investors that looking for:

- income
- Actively managed exposure to a variety of asset classes
- Where the asset allocation reflects offshore and equity exposure, the portfolio is exposed to currency and equity risks.
- The portfolio is exposed to default and interest rate risks.

The portfolio is unlikely to be ideally suited to investors with a time horizon less than 5-7 years or investors that are uncomfortable with investment value fluctuations over the short term.

Therefore, it is suitable for long term investment horizons. The expected potential long-term investment returns are lower but less volatile over the medium to long term than pure equity portfolios




